## Service Terms

---

The Service Order and the Service Terms below comprise the entire agreement ("Agreement") between you and Ultimate Wellness Web Sites, LLC ("UWWS"). The Ultimate Wellness Web Sites, provided through UWWS, include general wellness content and patient education materials. The Content is provided to your website under a nonexclusive license and subject strictly to the terms of this Agreement. This Agreement is not effective until accepted by UWWS, and is governed by Arizona law without regard to its choice of law principles.

**Monthly Web Site Service Fees** ~ The monthly service fees cover monthly hosting, customer support, technical support, and email support, and are payable on the first day of each month of the Agreement Term. Monthly fees are subject to change at each renewal Term as determined by UWWS. Advance notice will be given prior to price changes.

**Billing** ~ Billing begins as soon as your account has been setup and posted online. It is your responsibility to ensure that the credit card on file is updated and current. Late fees of \$25 will apply to declined transactions that are not settled within 30 business days of an email notice. Accounts that are not paid within 30 days will be temporarily suspended until the account is brought current.

UWWS may immediately cancel the Agreement, if an account has more than three payment failures in a year or the account is not brought current after notification. UWWS reserves the right to turn accounts over for collection including recovery of the cancellation fee, and pursue all legal and equitable remedies against you, including without limitation, injunctive relief.
